### Contractual terms

All order content, except where mentioned otherwise, is provided based on automatically renewing subscriptions. The service is purchased and delivered for a three-year initial Minimum Subscription Term, or a two-year initial Minimum Subscription Term, or a one-year initial Minimum Subscription Term, as selected by the Customer during the order process.
